Prof Simon Leunig, pro vice-chancellor, president and chief executive of Curtin Malaysia, and Dr Veerinderjeet Singh, president of MICPA, signed on behalf of their organisations via a virtual signing ceremony.

Furthermore, among the advantages of pursing a master's immediately after a bachelor's is that you get to mingle with industry professionals before you enter the workforce. You will get the opportunity to meet and interact with individuals from various industries and companies that you can build connections with. These connections can be useful in meeting possible clients, forming future partnerships and possibly gaining referrals to new jobs.

Although getting a master's early on can be a boon to some, there are some cons on getting a master's immediately.

Among the first cons is that you may dive into a course or specialisation that you do not enjoy or does not support your dream career. First of all, if you are unsure of what kind of specialisation you would like to go for, rethink your decisions until you can be


more confident about your choice.

A master's degree should only be pursued if you have a specific goal in mind that requires a certain specialisation to achieve. Enrolling for the wrong specialisation will only end up wasting your money and time.
The second caveat is that by pursuing a

master's without prior work experience, you are basically working blind. Without relevant work experience, your prior knowledge is based only on source materials instead of first-hand knowledge and experience. This can lead to possibilities where you struggle to fully grasp key concepts or relate to your peers who may discuss events that occur at the workplace.

And finally, if you already have a loan to settle from your bachelor's, pursuing further tertiary education is going to increase that loan considerably, putting you in a bigger debt. Even if you managed to complete your bachelor's with a scholarship, a master's degree is still costly and is not something that an average person can pay off in a pinch unless they have some savings that they can use to help alleviate the costs

With all being said, is it better to pursue a master's degree now or later? That answer will depend on your personal preference and circumstances. Whatever your decision, a master's degree is a worthy investment that will pay off later in your career. What you must keep in mind is that it is not a decision to be made likely, and detailed preparation and planning is required in order to make the most of the opportunity.

IN my previous column, I reflected on some of the challenges we face as the Covid-19 pandemic continues to reshape much of our daily lives. I also nodded towards the bigger issues to come, what are often called the 'long tail' of Covid-19 – those social, economic, and political challenges that are building up and are yet to be fully known.


At the risk of spending too much time talking about this subject, I have been giving a lot of thought recently to two pressing questions that are on the minds of many of our academics at University of Nottingham Malaysia (UNM). First, how will the economy recover? And second, what shape will our economy take in the future?

We are under no illusions. The world economic impact of Covid-19 has been nothing short of seismic and eclipses the shocks felt after the last great world recession of 2008. Some figures suggest that global poverty rose by 120 million people in 2019-2020 with hopes of improvement this year dashed by the continuing need for lockdowns in several parts of the world. In Malaysia, those in insecure or informal employment have often been hit hardest, with around 47% of the self-employed losing their jobs.

A report evaluating social protection for the vulnerable, produced by the think tank IDEAS last year, found that Malaysia and much of the rest of the world had been very effective at producing measures for people to cope with the immediate impact of the pandemic. Coping strategies are important, but they are necessarily short term in their scope. They provide us with the water to put the fire out.

As we begin to plan our way out of this

period and think towards the future, we need to consider what strategies will enable us to adapt. This means giving careful thought to what our 'new normal' looks like, especially in terms of the economy we will all participate in.

For many, this might include a focus on skills and reskills training. In time, we will also need to consider the longer-term focus on strategies that mitigate. How ready will we be the next time there is an economic shock of this magnitude?

These issues relate to the second question. What does the future of our economy look like?

In any reading of history, we can see significant societal transformation after significant periods of disaster. The UK's introduction of a welfare state after the Second World War is one such example: it changed the very fabric of society.

In the present day, as we begin to think about our adapt-and-mitigation strategies, economies the world over have a chance to reboot in new ways. The drive towards ensuring that our economies are fairer and that nobody is left behind is certainly a good aspiration. So too is a necessary and urgent focus on sustainability: the economic decisions we take today will shape the world that is to come.

In May, I was pleased and proud to see UNM sign a memorandum of understanding (MoU) with the United Nations Global Compact Malaysia and Brunei. This partnership signalled our common agenda to promote sustainability and the UN's Sustainable Development Goals (SDGs) in business and society.

Sustainability is more than ensuring biodiversity and the reduction of carbon emissions. It encompasses all the many

things that enable a society to thrive and sustain. This includes reductions in hunger, poverty, and poor health, increases in access to education, decent work, and affordable and clean energy, and so on.

The partnership will ensure that UNM will continue to do its part in shaping the conversation about what kind of future society and economy is needed to ensure sustainability.

I would also encourage everyone reading this column to have a look at the UN SDGs and consider how we all, through our actions and decisions, can contribute towards a more sustainable society. In doing so, we will be on a much better footing to both adapt and mitigate in these new and uncertain times.

Scholar's road to awards and recognition

ACADEMIC Assoc Prof Dr Nantha Kumar Subramaniam made Open University Malaysia (OUM) proud when his paper on the use of adaptive learning and artificial intelligence to transform learning won the Gold Medal for Best Practice Award at the 34th Annual Conference of the Asian Association of Open Universities.

The Conference was hosted virtually by Open University of Sri Lanka from June 1-3.

Dr Nantha's research paper entitled, Explorelets: Context-Aware Intelligent Adaptive Learning System for Online Learning, discussed his efforts in developing a coursework which he terms as "Explorelets" that helps learners improve their object-oriented programming skills.

"The Explorelets also provides learners with instant feedback to correct erroneous understanding of the lesson. They are useful as they create a dynamic learning path. For instructors, they are a good way to keep track of the learners' progress," explains Dr Nantha.

He says that adaptive learning stands out as one of the more promising e-learning trends that OUM is exploring as part of its continuous effort to enhance teaching and learning.

"I felt very happy as my work, which took almost two years, finally paid off. The award will reinforce OUM's position as an undisputed leader in online learning, with innovation and creativity as the main pillars of the university's academic culture. It is also a testament to OUM's excellence in online teaching and learning," he says.

Dr Nantha's efforts have also been recognised by other organisations and academic circles. Another Explorelets-related project won him a special award under the Outstanding e-Learning Project/Product category at the 2021 International University Carnival on E-Learning, which was hosted virtually on June 15 and 16 by a local university, and co-organised by Majlis E-Pembelajaran IPTA Malaysia and Jabatan Pendidikan Tinggi.

STUDENTS worldwide affected by campus closures are responding to roll calls from their lessons online. With this sudden shift away from the classroom and residency training, some are wondering whether the adoption of online learning will continue post-pandemic, and how such a shift would impact the teaching and learning in medical education such as acupuncture.

When the pandemic hit Malaysian shores in the first quarter of 2020, there was a marked rise of e-learning in the global education landscape, where teaching and learning is undertaken remotely and on digital platforms.

IMU's Master of Science in Acupuncture (MSA) programme which is blended learning-centric, has been tackling the challenge that came with the Covid-19 pandemic. This led to a massive shift in online learning operations.

The programme's students have shared their insights on online studies while working as full-time healthcare workers during these trying times.

A year into online learning, Dr Loh C.H. says the setting has made her learning so much easier. She does not have to worry about travelling to KL every week to attend class. Instead, she relaxes at home on the couch and listens to the online lecture.

She is grateful of the flexible learning which provides ample time at her own space, a big relief for her when she is juggling between work and study in these challenging times.

She describes her online learning as a superb experience with easily accessible materials and recorded lectures available any time, anywhere on demand. She also feels less stressed and more relaxed without the time-bound factor.

Similarly, a medical officer working in a district hospital, Dr Que J.Y., says studying this programme is a brand -new experience. Weekend online classes and virtual practical demonstration of acupuncture techniques through synchronous learning are easy to follow with the university's e-learning environment.

He says the availability of recorded lectures is an upside as he can replay and recap prior learning at ease without worrying about missing anything. Online classes are not inferior to conventional classes, he concludes.

Dr Ng W.K. says there has been prompt response at every stage with regards to the revised learning schedule and believes online learning will continue to be a key part of the university's learning model.

Dr Gan C.L. agrees that the new normal in learning brings its own challenges and adjustments. She sees the main challenge as maintaining the same level of discipline in her studies while coping with family and a hectic work schedule as a frontliner.

In a nutshell, students responded that these online sessions break monotonous routines, provide flexibility of time and the material is easy to access. They feel motivated to read on those topics at their own convenient time with easy access to materials and it helps them plan their work-study times. The most frequently mentioned factor hindering learning is the limitation on the number of practical sessions, which has been addressed through remedial sessions when students are allowed to return to campus eventually.

The Covid-19 pandemic has made the university realise the importance of online training for part-time postgraduate students. Apart from gaining knowledge, the present fluid situation reveals the impact of online learning on the morale of students by creating a diversion from the impact of the pandemic.

Online teaching is feasible, cheap and must be made a part of the postgraduate training going forward beyond the prevailing lockdown.


